

MINUTES OF THE HINGHAM ANNUAL TOWN MEETING
HELD ON TUESDAY **20 April 2021 at 7.30pm**

7 members of the public attended the meeting including District Cllr Bendle and County Cllr Dewsbury and representatives of the Town Council

(Copies of all reports submitted were available on the Hingham Town Council website prior to the meeting and are published on the Hingham Town Council website as Appendix A to these minutes).

1. Welcome, and to Receive Apologies for Absence

The Chairman opened the meeting and thanked everyone for attending. Apologies for absence were received from Alison Lys, Jane Mackie, Town Cllrs Steph Amey and Christine Dunnett, Hingham Primary School Head Teacher Vickie Newrick.

2. To Approve and Sign the Minutes of the Annual Town Meeting of 16 April 2019

The minutes were agreed as correct, the Clerk will arrange for them to be signed by the Chairman.

3. Matters Arising from the Minutes of the Annual Town Meeting of 16 April 2019

The Clerk advised that the Good Neighbour Scheme was no longer in operation.

4. Address by Hingham Town Council Chairman including:

4.1 To receive a summary report from the Chairman on the work of the Town Council during the past year and its plans for the future. (see Appendix A).

The Chairman's written report was published on the Town Council website prior to the meeting. The Chairman reiterated his thanks to everyone who had given support to residents and who had helped keep all of the essential shops and services operating throughout the pandemic. The Chairman added that he would also like to thank Dereham Foodbank for all of their guidance and help toward the Hingham Emergency Packages scheme.

4.2 Draft accounts for the financial year 2020/21 (see Appendix A)

The draft Town Council year end accounts for 2020/21 were published (with the reports) on the Town Council website prior to the meeting.

5. Open Forum to Discuss Matters Raised by the General Public

No matters were raised by the public.

6. To Receive Reports from Hingham Clubs, Societies, Charities and Organizations etc. (See Appendix A for the written reports submitted and published prior to the meeting)

The Chairman asked if anyone wished for him to read the reports out to the meeting, no such requests were made.

Any additional comments made are noted below.

6.1 SOUTH NORFOLK COMMUNITY CONNECTOR

Thanks was offered to Barbara Howard the Community Connector.

6.2 HINGHAM PRIMARY SCHOOL

It was noted how lovely it was to hear that the children attending the Primary School were doing so well and adjusted brilliantly to all of the changes that the pandemic has brought. It was also noted that

the Staff had done an amazing job, going above and beyond to make sure that the children could continue with their learning and be supported.

6.3 HINGHAM & DISTRICT COMMUNITY CAR SCHEME

It was noted that the scheme had been exceptionally busy helping to take residents for their Covid jabs, thanks was offered to the coordinators and to all of the volunteer drivers.

6.4 HINGHAM EMERGENCY PACKAGES

A representative of Hingham Emergency Packages spoke to advise that the scheme was aiming to wind up their work in June, having provided emergency support for over a year. The remaining funds will be held in obeyance for a year, (it was noted that the Community Connector could hold funds and ring fence them to help people in Hingham). People who have received help through the scheme had expressed their gratitude. Thanks was offered to the Community Connector for helping to refer clients to the relevant authorities and to Dereham foodbank for their help and support. Thanks was also offered to all of the volunteers who had helped with all aspects of the running the scheme.

6.5 LINCOLN SOCIAL CENTRE

A representative of the Lincoln Social Centre spoke to advise that the hall had undergone some internal decoration and new stage curtains were being installed, with hopefully new window curtains to follow, the building also had WiFi installed. It is hoped that the improvements will make the hall a more multi-purpose event worthy venue, and it was hoped that it would be used by amateur dramatics, film and arts groups, for music gigs and more events like the comedy night. It was noted that the committee had a new Chair and Treasurer who were enthusiastic about making improvements to the hall.

District Cllr Bendle congratulated the Lincoln Hall committee on their work, and advised them to get in touch if they thought South Norfolk Council could assist with grants.

A request was made to ask the committee if a different cooker could be purchased, it was noted that the cooker was the emergency cooker for the town and therefore needed to be able to work in a power-cut situation.

6.6 MILL FARM ALLOTMENTS

It was noted that all allotments are now let and being worked on.

6.7 THE HINGHAM SOCIETY

A representative of The Hingham Society reported that 2 committee members had stepped down, including Chairman Tom Cowin, the future of the Hingham Society (created in 1972) now looked uncertain, but the committee hoped to attract new members to enable events to take place and the society to continue.

6.8 HINGHAM W.I.

It was noted that the art group had items in the new Harrods of Hingham Gallery. Thanks and congratulations were offered the organisers of the Harrods of Hingham Gallery.

A representative of the Community Speed Watch advised that they were in need of some new volunteers. Concerns were raised regarding the effect that the largescale housing development in Great Ellingham would have on local traffic through Hingham.

6.13 HINGHAM ROAD SAFETY CAMPAIGN

A representative of the Hingham Road Safety Campaign advised that the group looked forward to having discussions with the Town Council regarding a holistic approach to the road safety issues in town.

6.14 HINGHAM PLAYING FIELDS ASSOCIATION

It was noted that it was good to hear that the sports clubs were starting to get up and running again following the sports centre closures due to Covid. A representative of the Hingham Playing Field Association advised that the toilets had been refurbished, but this took longer than anticipated due to Covid, and the electrical work had been done. The football club had folded, but was now getting back up and running and is working with the Cricket Club. The Sports and Social Club bar has re-opened, serving customers seated outside as per the current restrictions. The Covid grants meant that the HPFA was in a better position than they would of otherwise been.

7. To receive Annual Reports from County and District Councillors

7.1 District Councillor Yvonne Bendle

District Cllr Bendle reported that South Norfolk Council staff had been very heavily involved in the Covid pandemic response work. The Help Hub had received over 18,000 calls and one of the main reason for calls was residents needing help with prescription collections. Cllr Bendle praised the efforts of everyone involved including all of the community groups and volunteers that helped their communities. A huge number of Government Covid grants were given to businesses in the district to help to keep those businesses going.

As community groups have been less active, the unspent Members grant has been rolled over and Cllr Bendle would be glad to hear of any groups who needed a grant. £12000 had been given to the Hingham Playing Field Association to help with the refurbishment of the toilets.

South Norfolk Council were now putting a Covid recovery plan in place, with a "breathing space" initiative to help people manage debt, including Council Tax arrears and working with the DWP to help people who are out of work to find jobs with the 'Kickstart' work for all job scheme. A new computer system is being set up for the housing register and SNC are braced for an increase in homelessness.

SNC are looking at ways to improve town centres to help the businesses recover from the effects of the pandemic, Cllr Bendle noted that Hingham was lucky as many businesses continued to operate.

It was reported that there is a new Primary Care network scheme as the South Norfolk Clinical Commissioning Group no longer exists. The new scheme will provide some funding toward the Community Connector Scheme. South Norfolk is the only district to provide Community Connectors that offer face to face help, and the Connectors are now able to reach people with debt issues and refer them to the debt advisors (additional debt advisors have been employed).

South Norfolk Council are piloting a scheme to help to support people to get back home from hospital sooner, to prevent bed blocking.

A query was raised from a member of the public regarding the specialist housing on Hardingham Road, Cllr Bendle advised that this was not something that SNC was involved in.

7.2 County Councillor Margaret Dewsbury

County Cllr Dewsbury had submitted a written report (see appendix A), and added that there was no information on the specialist housing on Hardingham Road as Norfolk County Council had not taken on the housing scheme.

The Clerk asked if Cllr Dewsbury could investigate why Hingham Library was being prevented from re-opening to allow customer access, inline with all other libraries in Norfolk, as there was no indication on when the library would be permitted to provide anything other than a doorstep service, which was preventing public access to the free computer use.

8. To Discuss Any Other Business

A member of the public asked if the Town Council had heard anything following their representations submitted to the Greater Norwich Local Plan Regulation 19 consultation. The Clerk advised that she had written to the GNLP team to invite them to visit Hingham to meet to discuss the issues raised "in situ", and that the GNLP team had declined.

District Councillor Bendle advised that the GNLP consultation was regarding the soundness of the plan and the Town Council had "not got anywhere with that" because the Town Council representation was regarding the site selection and was not on the soundness of the plan, and covered things that would be dealt with during the planning application process. Cllr Bendle advised that there would be an opportunity to make representations when the plan goes to the planning inspectorate, but that might be in 2 years' time and all parish councils will be advised.

The Chairman advised that the Town Council had commented on the soundness of the plan and that the site selection was unsound, as the representations raised by residents were as not in favour of the Norwich Rd site being developed, in particular with regard to the flooding issues.

Cllr Bendle was asked if she had read the Town Council representation document, Cllr Bendle advised that she had read some of it and it was much the same as the previous representation document.

District Cllr Bendle added that the flooding the Town Council had referred to was nothing to do with the GNLPS as they only consider flood plains when assessing sites and the Town Council were raising issues with surface water flooding occurring on Seamere Rd and the track/public footpath which is affected by surface water because there is no surface water drainage on Bears Close, Cllr Bendle noted that issues can be caused with new developments if people change their driveways as it can alter surface water movement.

A Town Cllr responded to say that it is a matter of competence if desk top assessments can be made that effects 2000 people and those people have no comeback , for the GNLPS not to engage further is despicable.

District Cllr Bendle again said that the issues the TC had raised would be dealt with via the planning application process.

The Clerk advised that the GNLPS site selection information for Norwich Rd specifies that the site requires heavy flood mitigation, and it was raised that there is surface water flooding issues existing on Seamere Rd and that the mitigation for surface water in the Hops had not worked, therefore the mitigation via planning is not effective.

Cllr Bendle advised that the GNLPS would not deal with surface water on the Hops as it was a different land (i.e not in the GNLPS) and she was not aware of flooding issues on the Hops (it had not been reported to SNC). A Town Cllr advised there had been flooding of gardens and garages.

Hingham Town Council - Chairman's Report 2020/21

The past year has been different from anything that those of us living today have ever seen. In many ways, we as a Community, have come together to support others around us.

Normally, at the Annual Town Meeting, I would be awarding the Chairman's Award for Services to the Community, but this year there are so many people and organisations that I would need to recognise, therefore I hope that I can express my sincerest thanks to all the shops that stayed open and feed us in these difficult times, Hingham Helpers, Hingham Emergency Packages, Dereham Foodbank, the Posties, the refuse collectors, milk delivery, paperboys and girls, organisers of the Hingham Parish Magazine. Thanks also goes to the Community Car Scheme who have been busy taking people for their jabs; the churches, the doctors and the school, the fire service for providing the NHS with extra drivers and both the District and County Councils. If I have missed your organisation, please accept my apologies and my thanks. Whilst offering thanks I can't forget Ali and David, the Council's employees, and of course my fellow Town Councillors (past and present) and the District and County Councillors.

The Town Council has continued to operate; if not in its normal way but by Zoom and email. Some Councillors decided it was the right time to leave the role and we have welcomed some new faces onto the Council.

With the ever-increasing cost of a whole range of goods and services, the Council gave careful consideration to their 2021/22 budget and took the decision not to increase the Council Tax parish precept requirement.

There have been several issues that have been exercising our concerns but the main one recently has been the Greater Norwich Local Plan and the effect it may have on Hingham. We initially put together a response to the various areas of land put forward for development, in particular the GNLP preferred options. Norwich Road (area next to the Hops), which the Council and many individuals felt was the wrong site to develop. We had concerns about the feasibility of highway requirements in order to develop some land offered on the Dereham Road. The 2 sites were however carried forward for development on to the next stage of the GNLP process (with the intention of including them in the adopted Greater Norwich Local Plan). The Council once again wrote to the GNLP team, putting forward a case for rejecting these sites, and for infrastructure improvements for Hingham to help support future development. The next stage is for the GNLP to be assessed by the Planning Inspectorate. (The landowner has requested the Dereham Road site be withdrawn from the GNLP).

We are waiting for the Highways department to report on the feasibility of improvements to the Fairland Junction and a possible pedestrian crossing in the Market Place. If it proves that these improvements are feasible the Town Council will be campaigning to the County Council for a commitment for some work to be undertaken.

The Town Council are investigating the possibility of undertaking a Neighbourhood Plan. This would take some time to produce, but may enable the community to have a stronger voice regarding where future development takes place. We are looking forward to a time where there are fewer Covid restrictions and therefore the Council can hold meetings again in person and get the Climate Emergency and Environmental Working Party up and running and undertaking suitable projects. We may also from time to time look for volunteers to help with various projects, and welcome residents' attendance at Town Council meetings. We look forward to hearing that the various Clubs and Organisations in and around Hingham are able to meet again (and find new members and volunteers), as they all help to make Hingham a lovely community to live in.

This year, like everyone else, the Early Help Hub and Community Connectors have reacted to an extraordinary situation, a global pandemic, that none of us could have predicted.

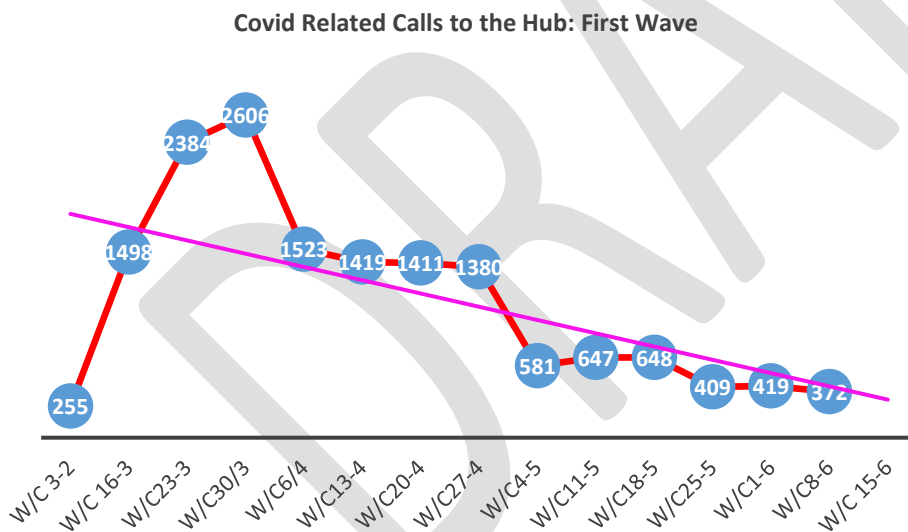
During the first lockdown the Early Help Hub was getting hundreds of calls a day and there has always been someone at the end of the phone making sure no call went unanswered and vulnerable residents received the food and medicine they needed.

As your Community Connector I have continued to deliver social prescribing within the GP surgery and the Hingham community. I have supported those who were shielding or self-isolating as well as those who have been impacted by the pandemic in other ways; whether this has been to support residents to access their community by connecting them to social networks, helping them improve their wellbeing, accessing grant funding, combatting loneliness, carers support and more:

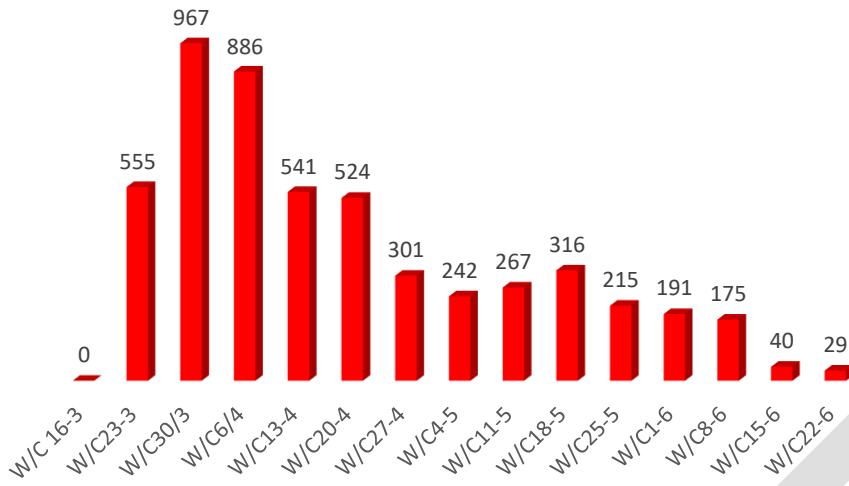

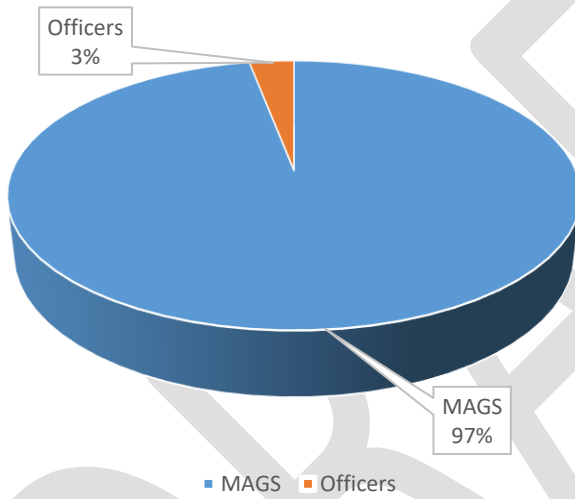

Hingham Primary School April 2021

It has been a very different year in school, but despite everything a very positive year.

This time last year we, along with all the schools in the country, were instructed to close. I don't think for one moment we thought that we would still be closed into the summer term, but we were. During this time we were open for vulnerable children and children with key worker parents (e.g. NHS workers, teachers, police officers, care workers etc).

During this time our building work began. The old dilapidated mobile classrooms were removed and the ground work began to install a 3 classroom modular block.

In September our new building was handed over to us with only 2 days prepare for the new term. Whilst the initial stages were somewhat challenging to be able to get everything organised, we were able to open on time on the 7th September to a full school. The pleasure and delight of having everyone back outweighed the challenges of creating Covid-safe school.

The building has made such a difference to the way we are able to run school and gives us so much more useable space. The new block is purpose-built for EYFS and KS1 and has access from every classroom to an outside area.

The older part of the building houses KS2 and we made the sure that they too had a refresh with some new loos, new double glazed windows and every classroom being painted.

September to December worked brilliantly with children engaging well in learning and getting back into routine. The children were amazing.

With January 2021 came lockdown and school closures again. This time we were well prepared and were able to roll out online live lessons by the first official day of closure. Over 700 live lessons, breakout rooms and many Parent-mails later, we returned to school in person on the 8th March. The feedback from families during this time was really positive and most children engaged daily.

Whilst we are still organised in class bubbles that don't mix, we are delighted to be back in the building and teaching face-to-face, hearing the sounds of children learning and playing together – back to how a school should be.

HINGHAM & DISTRICT COMMUNITY CAR SCHEME

REPORT TO HINGHAM TOWN MEETING - FOR 2019/20 AND 2020/21

The Scheme covers Hingham, Deopham and Hackford offering transport for medical journeys to Hospitals, Surgeries, Dentists, Chiropodists, Osteopaths and chemists. Journeys are charged at 50 pence per notional mile with clients paying half, whilst the rest is covered by funds from Hingham Council, South Norfolk District Council and Norfolk County Council.

Our drivers are volunteers, who use their own vehicles and offer their time free. They receive half the cost of the journey from the client at the time of the journey and receive the second half monthly by direct payment to their bank account. These payments are drawn up by the scheme administrator from the booking diary, authorised by the scheme co-ordinator and paid by the finance officer by internet banking.

April 2019/ March 2020

There were 1,167 journeys carried out during the year at a cost of £3,200.50 to the Councils – 50% of the total cost of running the scheme. This is about normal for the scheme, the only difference is that we now count each return journey as 2 journeys, to come into line with other schemes funded by SNDC.

During this year we had four main drivers and two who took on journeys when there was particularly high demand.

April 2020/ March 2021

There were 796 journeys carried out during the year at a cost of £2,657.75 to the Councils – a significant reduction reflecting the impact of Covid-19. It is a matter of considerable pride that our drivers continued to offer their support throughout the various lock-downs – we believe that we are one of the few local schemes that did this.

During the year the main drivers continued to offer their support, but towards December when the first tier started the national vaccination process we realised that we may need more drivers to meet the likely demand. Advertising on the Hingham Facebook Page resulted in six new volunteers of whom three are able to take on journeys regularly. Indeed the first three months of 2021 accounted for almost half of the total journeys in the year.

In May our administrator, Kalea unfortunately had to resign and the Co-ordinator took on the role while we advertised for a replacement. At the end of September we were very fortunate to take on Carol as our Administrator who picked up the reins quickly and provides excellent support to both our drivers and clients. During the difficult days of Covid-19 she has particularly helped our most isolated and vulnerable in the community, maintaining regular telephone contact with them and undertaking regular acts of kindness when needed, such as shopping or picking up prescriptions. She is always ready to go the extra mile to help our clients.

The Scheme is currently in a good position to maintain its service and continues to provide support within the communities of Hingham, Deopham and Hackford.

Hingham Emergency Packages Report for Hingham Town Meeting April 2021

Hingham Emergency packages was set up at the start of the pandemic as a response to the economic impact on families and individuals through loss of work and associated financial hardship.

A core group comprised of representatives from the church, the school, the White Hart and local volunteers, have provided over 300 food parcels to households in need. Our scheme has been funded entirely by donations from local people and businesses, to which we are extremely grateful. Our families have asked that we pass on their gratitude for this support, without which access to essential food basics could have been compromised.

We are also very grateful to Michael at Mid Norfolk Food Bank in Dereham, who has been a huge source of support.

The scheme will come to a close this June, with left over funds being held for a period of time in case we are needed again, after which the committee will distribute any leftover funding to a similar cause(s) with similar objectives.

The committee wishes the very best to all in the recovery from this most extraordinarily challenging year and hope for brighter times to come.

Report of the Hingham Road Safety Campaign (HRSC) to the April 2021 Hingham Town Meeting

Late last year we reported our two year campaign findings in the Community Newsletter and to the Town Council requesting, as residents asked, we collaborate to pursue matters with the County Council. A short reminder of what we recommend is included at the foot of this paper. Since then two vital events, a further Covid-19 lockdown and the Greater Norwich Local Planning (GNLP) final consultation phase on their housing proposals for Hingham have interceded, making round table discussions impossible while these were dealt with. We now look forward to meeting with Councillors in the next few weeks. The continued preference of GNLP planners for the Norwich Road development was not known when we reported and was therefore not covered by it.

We consider the B1108 Norwich Road is already unfit for purpose, let alone for an extra 80+ proposed houses, and used the consultation to produce a paper explaining our reasons. (Essentially it would lock in the present failings for ever.) We concurred with the Town Council's own objections and preferences and were able to agree our approach at the 'Zoomed' TC meeting in February. We hope that our additional arguments focusing on the speeding and other B1108 road issues will finally persuade the planners that this proposed development is "unsound".

A brief summary of our report recommendations:

Our small team set out to try and draw to a conclusion the long 30+ year, largely unsuccessful, struggle to secure improvements to road safety in Hingham. Speeding is at the core of this, compounded by difficulties in walking around the town where there are no pedestrian rights of way to cross a road that literally bi-sects our town and its amenities.

Lack of any major infrastructure investment in roads also sees footpaths that are frequently poor and unsafe - long before social distancing became an issue.

Reducing speed by 'natural' calming traffic at the town entrances and at regular intervals throughout the town is the core proposal. Providing a small number of pedestrian controlled crossings at the busier points is also key.

Improvements to footpaths will be the most challenging - but is possible, again with a determination to remedy the neglect in investment that accompanied much of the development of the Town over the years. We have recommended for discussion, refinement and development, how most of these improvements can be achieved. Obviously they need proper capital investment and this is why it will take all our combined persuasive powers to put our town in the frame for some remedies and better spending parity.

Report to Hingham Town Meeting 2020/21

The HPFA owns the Welcomme Playspace in Hardingham Street and the buildings and facilities offered at the Sports Hall and Playing Fields on the land at Watton Road, leased from the Town Council. It hosts a number of sports clubs including football, cricket, tennis, short mat bowls, badminton, all of which run as independent clubs, paying HPFA for the use of the facilities. The hall is also available for hire for private events and parties, and by individuals to hire for private use of the indoor courts. The Sports Hall includes a Sports & Social Club which operates separately under its own license.

The HPFA continued its efforts to update and upgrade its facilities, completing the electrical works in line with the full Electrical Report commissioned in early 2019. We have also completely renovated the ladies and gents toilets. We are now looking towards refurbishment of the windows and doors, which will require applying for grant funding.

With the onset of Covid-19 in early 2020, our sports clubs were all shut down. We implemented all required 'covid-safe' processes for access to the hall, including risk assessments, the NHS Test and Trace barcode, and sanitisers. This allowed family groups and 'bubbles' who were able to play outdoor tennis for example could access toilets etc.

At Christmas we were able to help the Rector host a small Carol Service in front of the hall, with everyone socially distanced on chairs. Over thirty people attended and it was a lovely event.

Each Club is following its national body's regulations for returning and we are asking them to submit a risk assessment if they need to access the hall. The Social Club has just started offering drinks outdoors on a limited number of days. The Cricket Club has held its first match.

On the financial front, we were able to benefit from SNDC's business support grants, and have therefore been able to keep solvent through these difficult months. We are grateful to them for their speedy and efficient release of these grants.

We have held three or four meetings during the period, either by zoom or a combination of a small group in the social club and zoom. We were very glad to 'see' Daisy and Yvonne at our last meeting in March. We are all looking forward to returning to full operation.!!

Norfolk County Council Annual Report 2021

Last year I wrote my annual report in April and finished it by saying 'dealing with the Coronavirus has completely disrupted the council's work and budget plans. We have responded to current needs and, like everyone else, we have no idea how long this will continue or when we will be able to get back on track.'

I don't think any of us imagined that we would not be emerging from this for a full year.

We will be balancing the budget this year because the Government has assisted with the financial demands of the pandemic but it has been a very different and difficult year.

For the last year staff have been working from home and many who had face to face roles, which had to cease, have been helping our other services, or the NHS with whatever needed to be done to help local people and businesses. They have delivered medicines and groceries, helped with testing and vaccinations and answered phone calls for assistance.

The Fire Service has driven ambulances, taught others to drive ambulances and set up and run a new mortuary when there were not sufficient to cope.

Museums, libraries, Records Office were closed but they set up and ran virtual visits, activities, etc to assist with the wellbeing of children and adults sitting at home.

Adult Learning put their courses on line and developed many new ones, to help people who had lost their jobs develop new skills and acquire qualifications as well as provide activities to support peoples' mental health and wellbeing.

The council funded and distributed 5,000 laptops and tablets for children who needed them to do school work at home and art packs were also supplied to keep them occupied and interested. Libraries set up a phone line to support families who were struggling with home learning and how to use the new digital devices.

Customer Services has assisted with the test and tracing to warn people who have unknowingly been in contact with people with COVID and we believe this service will need to continue for at least another year.

The council's usual work continued maintaining roads, supporting vulnerable adults and children and responding to emergencies such as the flooding during the winter.

The Norfolk Strategic Flooding Alliance has been set up to identify the causes of some of the flooding and help rectify them.

Libraries are about to open again. Recently they have assisted people to complete the Census on line and will be stocking the lateral flow tests in libraries and on mobile libraries when they start coming round again.

A new grant scheme called 'Go Digital' was launched in December to enable micro, small and medium sized businesses to make better use of digital technology by providing funding and one to one support and advice to help support the local economy.

Work has begun on two new recycling centres one to the north and one to the south of Norwich and some major road schemes are about to start in Gt Yarmouth, Downham Market and Stalham. The Long Stratton bypass has also been agreed.

The Member's Highways grant of £6,000 will be increased by £4,000 this year and extended to include environmental projects. The council has also agreed to plant one million trees over the next five years to reduce our environmental impact and meet our target of zero carbon by 2030. Parishes are asked to help identify areas where trees are required.

This is just a brief overview of some of the work of the council. I am always around to answer questions or help with any problems that arise and I endeavour to attend all Parish Council meetings but occasionally I have two or more meetings on one evening and cannot attend everything. The Parish clerks know they can contact me anytime and I am happy to help.
